

PSR PAYMENT SCHEDULE

Program:
Termination of Unsecured Debt —

Cost: \$ 500.00

1.) This program is right for you if you are looking for debt termination of unsecured debts that are in collections. You will also receive some basic education about the commercial world in which you live and conduct your affairs. You'll receive:

- Debt Account Termination ➔ with a "NOTICE OF DISHONOR" follow-up.
- Customer Support from **PSR** (1st 60 days).

2.) This program is for one (1) account requiring **Purple Sage Righters ("PSR")** prepare one (1) "debt verification" package ("DVL") for one (1) client (meaning you). EXCEPTION: If there is more than one (1) name (meaning additional clients) on the account, such as a joint-account with two (2) or more names on a credit card, there is no additional charge for the additional party provided both parties are married to each other. In this case, the joint parties on the single account are construed as one (1) client. This exception occurs **only** on joint accounts with the parties being married to each other.

3.) The fees expressed herein for all DV packages originally generated for each account desired discharged by you, the client, and also includes a follow-up NOTICE OF DISHONOR document generated to each debt collector together with all technical and customer service support needed for a period of 60 days from the date the DV package is generated by **Purple Sage Righters**, provided you have complied with all instructions. Without the purchase of another "debt verification" package (DVL) or other needful services by the client an additional \$ 100 per event or per document fee will be assessed for further technical or customer assistance on an already existing account (meaning: one (1) phone call or one (1) e-mail or an additional letter or the like constitutes an event). After 60 days **PSR** will consider the account to be closed and no further actions will take place without your specific request and payment.

4.) The fees expressed herein for one (1) "debt verification" package (DVL) originally generated for one (1) debt account desired discharged by the client and the follow-up NOTICE OF DISHONOR after all instructions have been complied with by the client. An additional "debt verification" package containing an "extortion warning" notice (EWL) can be generated in the very unlikely event the original "debt collector" or the original "creditor" decides (after the original DVL package has been generated for a particular account being terminated) to reassign the account to another "debt collector," other than the previous "debt collector," on whom the DVL package had been generated. Each additional "extortion warning" package, after the first (1st) package has been generated will cost the client an additional \$200. **PSR** does not accept liability for the reassigning of the client's "debt" accounts to other "debt collectors," which is an event that occurs in less than 5% of **PSR** cases, and for which there is no control over. Such a "reassignment" of a client's "debt" to another constitutes clear evidence that **PSR** technology works.

Termination of Unsecured Debt, All Additional Accounts —

5.) This program is for each additional account that is in collections requiring **Purple Sage Righters (PSR)** prepare one (1) "debt verification" package (DVL) for one (1) client and **PSR** has prepared a previous DVL package for a prior and different account.

6.) For A Cumulative Debt Burden Of Over \$ 40,000 Of Debt, An Additional Fee Of 1.5 % Over \$ 40,000 Will Be Assessed For The Client.

Termination of Student Loan Debt, Each Account —

7.) This program is right for you if you are looking for termination of “student loan” debts. You will also receive some basic education about the commercial world in which you live and conduct your affairs. You’ll receive:

- One (1) Account Termination ➔ with “NOTICE OF DISHONOR” follow-up.
- Upon your explicit compliance with instructions, you will also receive a NOTARIAL PROTEST, which is an U.C.C. CERTIFICATE OF DISHONOR, signed & sealed by your notary.
- Customer Support from **PSR** (1st 60 days).

8.) This program is for one (1) account requiring **Purple Sage Righters (PSR)** prepare one (1) termination package (SLP) for one (1) client.

9.) This program is for one (1) Student Loan Account requiring **Purple Sage Righters (PSR)** prepare one (1) “Student Loan Termination” package (SLP).

10.) The fees expressed herein for all SLP packages originally generated for each Student Loan desired terminated by the client and also includes a follow-up NOTICE OF DISHONOR document generated for the client to each Student Loan Administrator and all technical and customer service support needed for a period of 60 days from the date the SLP package is generated by **Purple Sage Righters**. Without the purchase of another SLP package or other needful services by the client an additional \$ 200 per event fee will be assessed for further technical or customer assistance on an already existing account (meaning: one (1) phone call or one (1) e-mail or an additional generated document or the like constitutes an event). After 60 days **PSR** will consider the SL account to be closed and no further actions will take place without your specific request and payment.

11.) The fees expressed herein for all SLP packages originally generated for each account desired discharged by the client also includes (if all **PSR** instructions are properly and completely complied with) a NOTARIAL PROTEST document for the client to have signed and sealed by their notary. **PSR** does not accept liability for the reassigning of the client’s “Student Loan” accounts to other “Student Loan” Administrators or “debt collectors.”. In such an extremely unlikely event, **PSR** does have specific technology to address that and will charge an additional fee for extending those services.

12.) The U. C. C. - 1 FINANCING STATEMENT document preparation is required by **PSR** for those clients seeking relief from the burden of Student Loan debt.

Program:

U. C. C. - 1 FINANCING STATEMENT Document Preparation (*single*) —

Cost: \$ 500.00

13.) This program is right for you if you are looking for protection of your material assets in the event of the breakdown or failure of any alternative program of “debt termination” you have sought whether by **PSR** or another “debt relief/termination” program. You will also receive some basic education about the commercial world in which you live and conduct your affairs. You’ll receive:

- One (1) U. C. C. - 1, FINANCING STATEMENT document preparation.
- Customer Support with **PSR** (1st 60 days).

14.) This program is for one (1) client desiring **Purple Sage Righters (PSR)** prepare one (1) U. C. C. 1, FINANCING STATEMENT document package for one (1) client. The U. C. C. - 1 document may be one (1) single page or multiple pages, whatever is appropriate for the client’s needs.

The fee for U. C. C. document preparation by **Purple Sage Righters** DOES NOT incorporate the cost for the client to file the U. C. C. document with the client’s state’s department of commerce or secretary of state. Such fees may range anywhere from \$10 to \$180, depending on the state in which the client resides. The client must do his own filing after **PSR** prepares the necessary U. C. C. - 1 FINANCING STATEMENT document.

This program is suggested for those clients holding unsecured debts, the value of which exceeds \$ 25,000.00, for which relief from the burden of the debt is sought.

This program is required for those clients seeking relief and/or termination from Student Loan debts no matter what the value of the overall debt burden.

Program:

U. C. C. - 1 FINANCING STATEMENT Document Preparation (*joint*) —

Cost: \$ 800.00

This program is right for you if you are looking for protection of your material assets in the event of the breakdown or failure of any alternative program of “debt termination” you have sought whether by **PSR** or another “debt relief/termination” program. You will also receive some basic education about the commercial world in which you live and conduct your affairs. You’ll receive:

- One (1) U. C. C. - 1, FINANCING STATEMENT document preparation.
- Customer Support with **PSR** (1st 60 days).

This program is for two (2) clients desiring **Purple Sage Righters (PSR)** prepare one (1) U. C. C. 1, FINANCING STATEMENT document package for two (2) clients. The U. C. C. - 1 document may be one (1) single page or multiple pages, whatever is appropriate for the client’s needs.

Program:
COURT Document(s) Preparation —

Cost: \$ 1,200.00

This program is right for you if you are within three (3) days (after) from receiving (a) SUMMONS and COMPLAINT document(s) from an attorney, indicating that a (contract/debt issue) law suit is, or is about to be, commenced against you. You'll receive:

- One prepared document package to address the issue of your timely response to the SUMMONS. The package may, depending on your particular set of circumstances, include: *(not every client will receive all of the following)*
 - ☞ MOTION TO DISMISS
 - ☞ MEMORANDUM IN SUPPORT
 - ☞ AFFIDAVIT IN SUPPORT
 - ☞ DEMAND THAT LAWSUIT BE FILED (if necessary)
 - ☞ AFFIDAVIT OF SPECIFIC NEGATIVE AVERMENT (if necessary)
 - ☞ INSTRUCTION ON HOW TO PREPARE, FILE, and DELIVER THE ABOVE DOCS
- **PSR** Customer Support (Up to 2 phone calls limited up to 1 hour each within the 1st 60 days or until completion of the hearing on the motion to dismiss — Additional time will be subject to an additional fee (prepaid) and is in the sole discretion of **PSR** Customer Support).

This program is for the client or clients who are enrolled, or intends enrolling, in a “debt termination” program with **PSR**. This program is not presently designed to assist those enrolled in a “Student Loan” program, as the need has not been demonstrated. This program **requires** a DVL package be sent the “debt collector”/attorney with an excess of sufficient time for a NOTICE OF DISHONOR being delivered the “debt collector”/attorney **before** the MOTION TO DISMISS documents are required being filed/served.

This program goes **no** further than the above documents being prepared and utilized by the client(s), as the lawsuit should then be dismissed for failure of the plaintiff stating a claim on which relief may be granted.

In the unlikely event that further court documents need be prepared, **PSR** will prepare additional documents, as required for the client, at the rate of \$ 50.00 per page, with a mandatory six (6) page minimum per document preparation, there are no exceptions.

Purple Sage Righters cannot and will not perform court documents preparation (or any other document preparation) under an unreasonable time restraint, whether brought on by the client or not. **Purple Sage Righters** is the sole determiner of what is an unreasonable time restraint.

Program:
Credit Repair —

This program is right for you if you have utilized **Purple Sage Righters** for “debt termination,” and you seek the remedy of “credit repair” or credit cleanup from those debts having been terminated by **Purple Sage Righters**. You’ll receive:

- Referral to **PSR** approved Credit Repair program who’s website can be found from their link on **Purple Sage Righters** home page.

This program is for the individual client who is enrolled, or intends enrolling, in a “debt termination” program with **PSR**, who desire their credit report being cleared of the derogatory reporting occasioned by those accounts addressed by **PSR**’s “debt termination” processes and their credit rating improved.
